If assistance is provided by Committee vessels and personnel, it is at the risk of the participants.

I acknowledge the fact that I shall have a USCG approved PFD for each member on board.

I hereby agree to all the conditions for the Quincy Bay Race Week Regatta and warrant that my crew will read and agree to the conditions. I hereby warrant that my yacht will be outfitted, equipped and handled in accordance with these conditions; that she shall have the required equipment aboard; that she is seaworthy in hull, rig, and gear; that she wil be competently manned.

In consideration of your accepting my Entry for the race, I do both for myself, my executors, my administrators, and assigns, waive and release any and all claims that I may have against the Quincy Bay Race Week Association, the race committee, the participating yacht clubs, their officers, directors, members, committee persons, volunteers, employees, agents, or any one or more of them or their executors, administrators, heirs, next of kin, successors, assigns, including any and all claims for damage caused by the negligence of any of them arising out of participation or that of my yacht in the regatta and its related activities, including pre-start and post-finish operations and shore activities, together with any costs and expenses including attorney's fees that may be incurred as a result of any such claim that any officer, member of my crew or one of my guests (or the executors, administrators, heirs, next of kin, and assigns of any of them) may have to assert together with any costs and expenses including attorney's fees with respect thereto.
